*Travel and subsistence repayments are made to reimburse actual expenditure for travel, meals and overnight accommodation unavoidably incurred as part of :

Motorcycle mileage is repaid at 24 pence per mile

The Council's allowances are recommended by an Independent Remuneration Panel. As a result, the Oxfordshire County Council's allowances reflect the Panel's view that 40% of a councillor's time is deemed to be voluntary
